Subject: Prohibition of Championship Participation for Non-Registered Skaters

Dear District Associations,

This is to bring to your immediate attention the strict adherence to the guidelines set forth by the Roller Skating Federation of India (RSFI) regarding the participation of skaters in any championship events organized at any level within your respective jurisdictions.

It has come to our notice that certain district associations have been allowing skaters who are not registered with RSFI to participate in championships. We would like to remind you that, as per the official RSFI guidelines, it is mandatory for all skaters participating in any championship (BE IT EVEN CLUB LEVEL) to be registered members of RSFI.

Therefore, we hereby instruct all district associations:

- 1. To ensure that only RSFI registered skaters are allowed to participate in any level of championship events.
- 2. To verify the registration status of each skater prior to the commencement of the event.
- 3. To maintain a proper record of all participating skaters, including their RSFI registration details, to be submitted to RSFI upon request.

Non-compliance with these directives will result in stringent action against the concerned district association and the organizers involved. The specific actions may include, but are not limited to:

- Suspension of the association's rights to organize future events.
- Disqualification of events where non-registered skaters have participated.
- Further disciplinary actions as deemed appropriate by the RSFI governing body.
